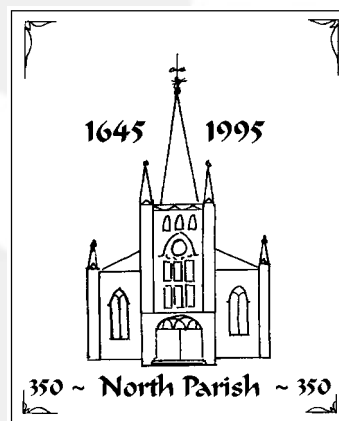

COMPOSER'S NOTES

- *This original piece was commissioned by the North Parish of North Andover to help celebrate their 350th anniversary. The words were provided by the minister of the church, Rev. David Blanchard...a good friend.*
- *The work is approximately 3:50 minutes in length (for the 350th!) and written for accompanied SATB Chorale.*
- *While creating the piece, I made several decisions:*
 - *The overall feeling of the work should be **joyous**.*
 - *Since the lyrics tell of the beginning of the North Parish, I created a 'frontier' type recurring motif.*
 - *The verses lent themselves to be 'through-composed' instead of 'strophic'.*
 - *To help emphasize the story being told (the history of North Parish), I tried to utilize a slower melodic rhythm and support it with a faster, more energetic accompaniment.*
 - *Regarding vocal pitch ranges: I intentionally kept the soprano part in the lower register until the end. The alto and tenor parts are not too high for either part while the bass part has some nice low notes.*
- *Overall, I consider this work to be very melodic while incorporating contemporary harmonies. After an initial solemn statement of the main lyrical motif, the robust frontier musical motif is introduced and then used as the 'glue' between each of the through-composed verses. The extended Coda section is contrapuntal in nature, finally reuniting harmonically for the ending.*
- *The premiere performance of this work took place November 4, 1995 at a celebratory concert at the church.*
- *The engraving of this work was done by the composer.*

I, Matt Johnson, (American pianist/composer, ISNI: [0000 0004 6875 3420](https://orcid.org/0000-0004-6875-3420)) fully intend to enjoy the copyright benefits of my works while I am alive. However, *upon my death* I will relinquish all Intellectual property rights, copyrights and neighboring rights, thus **bequeathing my entire catalog of creative works to the worldwide public domain**. Concurrently, I'll relinquish all copyrights for each sound recording found within my discography—which is officially listed on www.MusicBrainz.com—into the **public domain**.
